# Assembling microphone with a stand

ZYLIA ZM-1 has a detachable stand. You can disassemble it using 3/16 inch hex key. To assemble it back, simply insert stand in the device (you will notice positioning incision), then insert the screw and use a hex key to screw it.









# **Mounting options**

ZYLIA ZM-1 is equipped with a tripod. The device itself has 1/4" inner thread (compatible with camera stands – picture on the left side). Set includes also 5/8" to 3/8" adapter (inserted into the tripod) which is compatible with standard microphone stands (picture on the right side).

#### **LED** status indicator

The LED located on the equator of the device informs on the current status of the microphone.

- White light ZYLIA ZM-1 is powered
- Blue light ZYLIA ZM-1 is ready to use (driver is loaded)
- Red light ZYLIA ZM-1 is capturing data and sends them to the computer

On Windows operating systems blue light will appear after launching recording application (e.g. Reaper)

It is possible to dim LED or even turn it off completely using ZYLIA Control Panel, please refer to the relevant section of this manual.

# **Cleaning**

Clean the surface of the microphone with a soft dry cloth. To prevent damage to the finish or casing, do not expose the microphone to chemical products.

# **Driver installation**

ZYLIA ZM-1 requires correct driver installed before first use. It's recommended to use the latest version of the ZM-1 driver and to update obsolete drivers.

  - a) macOS 10.13 users must allow driver to be load:

    - Open Privacy and security settings
    - Click Allow



# **ZYLIA Studio**

ZYLIA Studio is an application designed to work exclusively with ZYLIA ZM-1 or ZYLIA ZM-1S microphones. Main features:



- Audio recording
- Separation of individual sound sources
- Mixing of the recordings (level adjustment, panning)
- Storage and management of the recordings

#### Installation

#### Instruction

- 1. Close other applications
- 2. Download the ZYLIA Studio installer package appropriate for your operating system. Download link: http://wwwm.zylia.co/downloads.htl
- 3. Run the installer and follow displayed instructions

Windows users should be aware that ZYLIA Studio needs Microsoft Visual C++ Redistributable 2015 to work. If you have this packet already installed, the installation of it will finish with an error but the installation of ZYLIA Studio will be finished successfully.

MacOS 10.14 and 10.15 users should allow ZYLIA Studio to use the microphone during the first launch of application.

#### **Activation**

ZYLIA Studio works in three modes:

- Demo the user may check general application workflow without using ZYLIA ZM-1 microphone. Functions such as recording or separation are unavailable.
- **Trial** all application functions are available for 7 days. The trial mode can be used once on the particular machine.
- Activated unlimited access to all application features. You can activate ZYLIA Studio on three different computers at the same time. You can deactivate it an unlimited number of times.




Activation process requires:



# Sound input/output


ZYLIA Studio 2.0 uses ZYLIA ZM-1 microphone as an input and default sound output chosen in your system preferences. You are able to change output device by clicking on the Settings – Change Output Device



#### **Start Session**

#### **Set up Session**

Before recording you will be introduced to the *Help* window. Here you will be able to learn the optimal positioning of the ZM-1 for recording, the *Audio Flow* which shows the different stages of the recording process and *Online Tutorials* which will lead you to ZYLIA online guides, tutorials and solutions.

The first step of the *Set up Session* is to select the preferred configuration for your recording. These configurations affect the number of separated channels for the Mix process and with a band configuration it also enables live source tracking.

- Band Solo, Duet, Trio, Quartet, Quintet, Sextet
- Surround Stereo Narrow, Stereo Wide, Stereo Binaural, 3.0 Surround Sound, 4.0
   Quadraphonic Sound, 5.0 Surround Sound
- Microphone Techniques Figure 8, Blumlein Stereo, Cardioid, Stereo XY, Mid-Side

# Recording

After selecting a band preset configuration, choose the instrument type to improve automix function results. You can set it by double click on sound source icon or in the menu at the bottom.

Choice of instruments doesn't influence quality of the recording and adds no effects.

ZYLIA Studio is now ready for recording. We recommend to turn off all other applications to ensure maximum audio quality. MacOS users should also disable Wi-Fi, Bluetooth, screen saver and option "Put hard disk to sleep" in their system preferences.

Press the red recording button on the left side of the screen to start recording. You can also enable *Live monitoring* option to listen a stereo preview of the sound captured by ZYLIA ZM-1.

We recommend using headphones for live monitoring in order to avoid acoustic feedback.


The live waveform and track will appear on the left panel, here you can listen the stereo preview of the track by clicking on the play button. Clicking record again will save the previous take and start a new one.

#### **Remote Control**

The Remote Control setting allows the user to start and stop recording via smartphone or tablet.

To use this feature you require internet connection on the device running ZYLIA Studio and your phone/tablet.

To access ZYLIA Studio remote control, click on the cog icon in *My sessions* view and under *Remote Control* select *Settings*. Toggle the slider *On and a* new window will open with the *Access Url* and *QR Code*. Type the Url access into the browser on your phone or tablet or use your QR code app by pointing the camera of your device to the QR code on the computer screen.



As soon as connection has been established, your device should open a new window with access to the VU meter and recording button. Press the RECORD button to start recording and the same button to stop the recording. A new recording will be added to your current session.





#### MIX


After the recording is ready you can separate the tracks of instruments. To start the separation process click on the *Mix* icon. This process results in the Auto-mix which quickly creates a ready to export mix based on the selected configuration and instruments.



You can also choose between two separation profiles in ZYLIA Studio:

- Profile 1 this profile is recommended for separation of musical sources. Beside
  separating sound for the particular instrument, it also cancels out sounds arriving
  from the other sound sources. Profile 1 results with full and genuine sound of the
  separated tracks with a minimized spill from the other instruments.
- **Profile 2** this profile works as profile 1 with additional noise filtering applied to achieve higher signal to noise ratio. It is recommended for speech and results with stronger separation of the sources.

Depending on the desired result choose between the above profiles. You can set separation profile by clicking on the cog icon in *My sessions* view and recording view.






In the Mixer you will see a master mix – at the top, and separated tracks of instruments – at the bottom. You can freely change the volume and panning of tracks. You can mute (M) or leave solo (S) track. All changes will appear in the master mix. You can also change the volume of the master mix. Additionally you have a 3 band EQ for each tracks.



Additional options can be found in the mixer's menu (three dots).

- MIX AUTOMATICALLY ZYLIA algorithm will adjust levels and panning of the separated sound sources,
- RESET ADJUSTMENTS will reset all sliders to their neutral (zero) positions
  including the master gain slider,
- UNDO SEPARATION will permanently delete the separated tracks. You can repeat
  the separation process later using different calibration settings or different
  separation mode,
- **EXPORT CALIBRATION** will export \*.zspro file with calibration settings used in the current session. Calibration file may be used later in ZYLIA Studio PRO.






# **Exporting**

#### Sound files export

Export of the recording is available from Mixer view.



- 1. Click on the EXPORT button
- 2. Select which type of the recording you want to export (you can select multiple options)


The following options are available:

Stereo tracks:

My Mix – customized stereo mix from the Mixer Stereo Preview – non-processed WAV stereo track.

- Solo tracks mono WAV files of separated sources
- All Solo Tracks to DAW Exports all solo tracks and creates a Project file for the specified DAW
- ZYLIA files and packages:




Clicking Export allows you to select a directory for saving the chosen files.






# **ZYLIA Control Panel**



ZYLIA Control Panel is an application designed for better control over ZYLIA ZM-1. Thanks to it the user is able to dim or even turn off the LED, check the device model and the firmware version. ZYLIA Control Panel is installed automatically during ZM-1 driver installation\*.

\* ZYLIA Control Panel availability depends on the operating system and ZYLIA ZM-1 driver version.



#### **Gain control**

Gain control is the ZYLIA ZM-1 driver feature which allows you to adjust the digital gain of ZYLIA ZM-1 signal. You can set it in ZYLIA Control Panel as well as in your OS facilities.

#### How to use it?

- 1. Open recording application
- 2. Check the sound level of the loudest sound source
- 3. Adjust gain of ZYLIA ZM-1 to the desired level remember to leave some headroom to avoid clipping. You can set it in:
  - ZYLIA Control Pan using the slider
  - Audio MIDI Setup application
- 4. Start your recording session.


# **Instrument placement recommendations**

To fully benefit from using ZYLIA Portable Recording Studio you are recommended to adjust the placement of instruments during a rehearsal. Below we present a few examples of good practice when record-

ing with ZYLIA.

#### Location

Sound sources (acoustic instruments, vocalists) must be located around the microphone keeping an approximately equal angle from each other and usually equal distance from the microphone. It is also advisable to locate sound sources in the optimal range of elevation. Sometimes it is good to check two or three different placements and choose the best one.



# +20° Optimal range of elevation

#### **Distance**

To avoid signal distortion from the microphone, it is recommended to place the ZYLIA microphone at a larger distance from a full drum set or loud instruments, 2-4 meters (6-13 ft). The appropriate distance can be tested by the user during test recordings. Signal distortion from the microphone can be monitored on the level meter in ZYLIA Studio.

Sound sources with lower signal levels than other should be located closer to the microphone.

Do not place the ZYLIA microphone directly on the ground, it is recommended to put it 1 m (3 ft) above the ground on a microphone stand. However, you can experiment with the set-up to achieve the best results.

#### Recording with amplifier


Do not use the same amplifier/ loudspeaker for two sound sources. You will not be able to separate tracks of those sound sources.

#### Recording of a single performer

If you want to record a single performer which is both playing on the instrument and singing at the same time, you should take it into account during calibration stage. In such a case you should calibrate two sources: an instrument and the voice. Make sure that your sources differ in elevation.

We recommend to place a single performer closer to the microphone

(<0.5 m), thanks to that the elevation difference between sound sources will be higher.



# **Troubleshooting**

#### **Important**

The Users are not allowed to make repairs of ZYLIA ZM-1/ZM-1S on their own. All repairs must be done in the service authorized by Zylia.

#### **Device is not lighting**

Your device is disconnected from a power supply (USB) or the LED ring dimming value is set to maximum.

No light on the microphone may also be caused by using a USB cable which is too long. You should only use the USB cable provided with ZYLIA Portable Recording Studio.

#### ZM-1 is not detected by ZYLIA Studio.

If after pluging ZYLIA ZM-1 to the computer the device is not detected by ZYLIA Studio, make sure that:

- The correct ZM-1 driver is installed
- You have changed your privacy and security settings (macOS)
- You have the restarted system after driver installation

Then check the connection using different USB ports and another USB cable. If the device is still not recognized by ZYLIA Studio, contact ZYLIA Support.

#### **Error appears during driver/application installation (Windows)**

ZYLIA software needs Microsoft Visual C++ Redistributable libraries to work. If you have those packets already installed, the installation of it will finish with an error but the installation of ZYLIA Studio will be finished successfully.

If you experience a different error during installation, please contact support@zylia.pl

#### I'm not able to allow ZYLIA ZM-1 driver to be load (macOS)

Other aplications runnig during installation process may cause inability to change Privacy & Security settings on your computer (especially Google Chrome or VLC media player). If you already finished installation of ZM-1 driver and you were unable to change preferences you should uninstall the driver using this deinstaller and install it again with other applications closed.

#### Processing and separation of tracks takes very long to complete

Processing of a recorded file can take some time if the recording is very long. It is recommended to split your recordings into short fragments, individual songs. A single recording should not be longer than one hour. The processing time depends also on the CPU capabilities of your computer. The uncompressed WAV/PCM format is limited to approx. 25 minutes in length after which ZYLIA Studio will create a new recording and continue to capture the sound. Please note that there might be a short pause between stopping the previous recording and starting the next one.

#### There is no recording in one of the channels

When recording to DAW, if you notice that there is no recording in one of the 19 channels, then one of the microphone capsules might be damaged. Please, contact ZYLIA Support.

#### Signal clipping

Signal clipping may appear during sessions with very loud sources. If you notice distortion in your recording you should put the loudest sources in the greater distance from the microphone. Use the meter in ZYLIA Studio to monitor input signal level.

#### Glitches in the recorded signal

The most common reason for glitches in audio is an inappropriate operating system configuration.

To ensure a maximum computer efficiency you should:

- Disable all energy saving options (e.g. screen saver, sleep of the hard disk)
- Disable Wi-Fi and Bluetooth some of the computers have those devices connected with USB buses, therefore they may affect USB data transfer
- · Record with computer plugged to the power supply
